Background

In March of 2022, the Foundation for Health Leadership and Innovation (FHLI), in partnership with the North Carolina Department of Health and Human Services (NCDHHS), awarded \$2.5 million in capacity building grants to 21 community-based organizations (CBOs) across the Triangle and Triad regions of North Carolina to support the growth of NCCARE360 and increase capacity to address social drivers of health (SDOH).

NCCARE360 is the first statewide network that enables a coordinated, community-oriented, person-centered approach for delivering care in North Carolina. It is a public-private partnership between FHLI and NCDHHS and is integral to DHHS's mission to improve the health, safety, and well-being of all North Carolinians. The funding was made available to NCDHHS through the CDC's investment to support communities affected by COVID-19 related health disparities. It is part of \$2.25 Billion provided through the federal **Coronavirus Response & Relief Supplemental Appropriations Act.**

NCCARE360 launched in March 2019 but rapidly expanded during the COVID-19 pandemic, onboarding more than 2,500 organizations and nearly 7,000 programs to ensure coverage across all 100 counties. However, due to the pandemic, many early adopters faced challenges utilizing the NCCARE360 network on account of limited staff and resource capacity, staff turnover, and a lack of comprehensive services available in their regions.



Mission



The NCCARE360 Health Equity Grants aimed to reduce barriers to health equity by fostering community connections through NCCARE360 and was designed as a proof-of-concept project, focused on finding gaps in usage, identifying best practices, developing community engagement strategies, and increasing partner adoption rates.

FHLI rolled out two distinct grant awards disseminated to organizations serving: Alamance, Caswell, Chatham, Durham, Forsyth, Franklin, Guilford, Granville, Harnett, Johnston, Lee, Orange, Randolph, Rockingham, Vance, and Wake counties.

Community-Based Organizations:

The CBO Health Equity Grant, the first distinct grant opportunity, provided organizations with between \$25,000 to \$100,000 to onboard or enhance their use of NCCARE360 and to foster cross-sector partnerships, enabling them to sustain existing programs like meal delivery, senior day programs, immigrant and refugee services, medical transportation services, interpersonal violence services, and more.





Community Impact:

Before obtaining grant funds, the majority of CBOs had not yet integrated NCCARE360 into their organizational workflows, with only 10 out of the 19 CBO grantees having been previously onboarded to NCCARE360. This funding allowed all organizations to hire dedicated staff to manage the referral management process.

Prior to March 2022, the already-onboarded grantees had managed 753 cases through NCCARE360. Over two-year grant period, the number of managed cases in NCCARE360 among all grantees surged to 7,878.





Some grantees encountered challenges throughout their projects. Many reported difficulties in recruiting and retaining staff during the grant period, grappling with understaffing and frustrations with technology. Some struggled with a high referral volume for services they couldn't provide, while others lacked sufficient community partners to receive referrals in their areas.

Despite these hurdles, the grantees successfully resolved 5,574 out of the total 7,878 cases, achieving a resolution rate of 70%. They discovered and adapted best practices for utilizing NCCARE360 to benefit their staff and clients, including the use of referral notes, chat, and light case management features offered in the NCCARE360 platform to track client progress and collect service data.

Davidson Medical Ministries (DC Connects) achieved a significant milestone by offering the **Volunteer Income Tax Assistance (VITA) program** to Davidson County residents from January to April 2023, leveraging NCCARE360 for referrals and assisting more than 1,000 community members in preparing and filing their taxes for free.

Community Building:



Grantees made a tangible impact on improving the overall well-being of their communities. Raleigh Immigrant Community (RIC) is one shining example.

RIC's impressive impact on employment placement services has helped more than 40 community members search for and secure jobs during the grant period. RIC shared that a refugee family of eight who relocated to Raleigh from Minnesota received comprehensive support from RIC who secured housing, employment, and access to essential services for the entire family. While reflecting on the health equity grant project, Felix lyoko, Director of RIC, expressed, "The funding provided by NCCARE360 has allowed us to further our mission of catalyzing and facilitating the integration process of refugees and immigrants while fostering a diverse and inclusive environment. With your support, we have been able to change many people's lives, host cultural community events to celebrate the rich tapestry of cultures represented within refugee and

immigrant populations."



Network Support Agencies:

The Network Support Agency Grants, the second distinct grant opportunity, established the creation of Network Support Agencies (NSAs), providing up to \$250,000 to organizations with specialized areas of knowledge and expert experience with NCCARE360 to provide community engagement, technical assistance, and professional support.

As advocates for NCCARE360, the NSAs played a pivotal role in guiding and encouraging CBO adoption. Leveraging their robust community connections, the North Carolina Justice Center (NCJC) solicited feedback on barriers and hesitations to onboarding from underserved communities, including the Latine community, immigrants, refugees, and individuals with sensitive legal needs. El Centro Hispano utilized their funding to bolster their Community Health Worker (CHW) Network.

The Duke SDOH Network hosted town halls to create open discussions about NCCARE360 and the National Institute for Minority Economic Development (NIMED) established networking sessions in Greensboro to garner community buy-in.



Through a combined 30 town halls, networking sessions, and other community meetings, NSA grantees collaborated with local groups to address gaps in NCCARE360 network implementation, as well as to champion the adoption of the platform by more community-based agencies. Their efforts boosted new partner adoptions across the Triangle and Triad regions. Prior to the grants' launch in March 2022, there were 947 partners using NCCARE360 across the targeted counties, covering a variety of service types including but not limited to: Individual and Family Support, Mental/Behavioral Health, Food Assistance, Housing & Shelter, Education, Benefits Navigation and more. Throughout the two-year grant period, adoption rates steadily increased by 320 new organizations, a 25% increase.



At NIMED's final networking session on May 30th, 2024, community members from various local organizations serving Guilford County expressed regret at the conclusion of these monthly meetings. Lisa Davis of Community Housing Solutions reassured her fellow attendees that while the sessions were ending, it was vital to sustain the partnerships forged during these monthly convenings, emphasizing, "Your work matters because the people you serve are your neighbors. Keep going."

Lessons Learned



Throughout this project, the NCCARE360 team gleaned valuable insights that are informing our overarching strategy to strengthen the network. Some initiatives include: introducing monthly general information sessions with scheduled demonstrations, developing an onboarding form to streamline the joining process, and initiating a reengagement strategy featuring community-led summits. These efforts underscore the importance of collaboration and localized expertise in enhancing the NCCARE360 network's effectiveness.

Through community-led engagement, we've discovered the power of collaboration and local expertise in addressing complex social needs effectively. Utilizing NCCARE360 for internal case management has highlighted the importance of streamlined processes and data-driven decision-making, enhancing the ability to provide comprehensive care.

Returning to a person-centered model from a health system focus has reinforced the significance of understanding individuals' unique circumstances and tailoring services to meet their specific needs, fostering trust and engagement.

Moreover, our strategic focus on 'receiving organizations' has underscored the importance of strengthening partnerships with entities that directly interact with and support individuals in communities.

Throughout the NCCARE360 Health Equity Grant project, significant efforts were made to provide grantees with robust professional development opportunities and comprehensive support, ensuring their success in serving their communities effectively.

The support extended to grantees also encompassed assistance with the renewal process for NC Solicitation Licenses, ensuring compliance with NC Secretary of State requirements. Recognizing that many Health Equity Grantee agencies were unfamiliar with this process, the FHLI Finance Manager took proactive measures to guide them through the requirements. Email reminders were sent to agencies one month prior to their license expiration dates, outlining the renewal process and steps to extend their licenses if necessary.
